- IX. IX. Member Reports/Announcements
 - a. Supervisor Plancarte expressed to the committee the following items:

- a. Street sweeping may kick off sometime in January – March, and will be done once a month, more information forthcoming.
 - b. The IV Healthcare District is considering applications for its board of directors. A Heber citizen may be considered if no one is selected from El Centro or Seeley. Applications can be found on the County’s website.
 - c. ICER is looking for a board appointment. Applications can be found on the County’s website.
 - d. An information board will be erected at Tito Huerta Park in the next couple of months.
 - e. There is housing development interest in Heber, and possibly reconsidering McCabe Ranch 1
- b. Ms. Curry expressed concern that no street sweeping is still an issue, has noticed abandoned cars are being removed, and meter readers seem to not check every meter.
